Background	<p>The CE (Continuing Program) is an on-going mandatory (per compliance 2 year cycle requiring 3-4 course certification per year) education certification program that spans the course of two years. Historically, LPL has offered a variety of means to advisors in order to qualify for the certification of the various CE tracks (there are 5 tracks and about 2-3 approaches per track).</p> <p>The complexity arises in managing the various permutations on how one can qualify for a course and then track as well as record the completion of a CE course. Advisors favor these options but both LPL and advisors feel the pain in dealing with the complexity when managing so many options. So, starting this new 2-year cycle in 2010 LPL is considering strictly offering the courses on-line while eliminating many of the other CE options including the option to take CE courses at conferences.</p> <p>Benefit for LPL: Managing CE courses on-line will potentially offer the following advantages</p> <ul style="list-style-type: none"> - Decrease FTE (Full Time Employment) - Regulatory control - Level set advisors through a holistic dashboard - Improved tracking of progress - Vendor tools for supporting CE Program including improved reporting <p>Benefit for Advisors:</p> <ul style="list-style-type: none"> - Improved tracking of progress - Any time/place to take a course - Increased options in taking non CE courses at conferences
Purpose	<p>Gather advisor reaction to the new CE concept where in all CE track can be accessed and tracked on-line only. Use advisor reaction to frame proposal that is to be pitched to internal LPL business stakeholders. These stakeholders will influence the endorsement of this concept.</p>
Target Audience	<ul style="list-style-type: none"> • IS/IAS Advisors • IS – Program Managers (as they oversee bank activities and although they are not licensed with LPL they work with licensed people and serve as a conduit to those impacted by the CE process) • IAS – Branch Managers (as they oversee the CE process) • Advisors who are not currently participating in on-line CE tracks
Approach	<p>Approach 1: Phone interviews with some survey type questions to capture metrics.</p> <ul style="list-style-type: none"> • Minimum of 7 questions and maximum of 12 • Participants: Maximum of 20 (10 IS, 10 IAS) <p>Approach 2: Standard survey with some comments to get qualitative feedback</p> <ul style="list-style-type: none"> - Participants: Mix of IS and IAS and reach out to as many advisors as possible
Facts	<ul style="list-style-type: none"> • On-line CE process may be potentially perceived by many advisors as a reduction in options
